COBALT IN NOVEMBER 2003

Reported consumption of cobalt in the United States during January through November 2003 was nearly equal in amount to consumption during the first 11 months of 2002, according to the U.S. Geological Survey. The cobalt content of U.S. imports of cobalt metals and chemicals was 11% lower in January through October 2003 than that of imports during the same period in 2002. The cobalt content of U.S. exports of unwrought cobalt and chemicals was 29% higher in January through October 2003 than that of exports during the same period in 2002. Trade data for November 2003 will be available in a subsequent issue.
