CEMENT IN DECEMBER 2016

This report provides monthly data on the shipments of cement to final customers and the production of clinker in the United States from January 2015 through December 2016.¹ Data on the imports of cement and clinker for December 2016 are also provided.

Total shipments of portland and blended cement in the United States and Puerto Rico in December 2016 were about 6.0 million metric tons (Mt), down by 8.6% from sales in December 2015 (tables 2A and 2B). The leading producing States for portland and blended cement in December 2016 were Texas, California, Florida, Missouri, and Alabama, in descending order (table 1A). The leading cement-consuming States (Texas, California, Florida, Georgia, and New York, in descending order) received 44% of the December shipments (tables 2A and 2B). Sales for the entire year totaled 93.3 Mt, up by 1.9% from those in 2015 overall.

Clinker production totaled 5.5 Mt in December 2016, down by 20% from the output in December 2015 (table 4). The leading clinker-producing States in December were, in descending order, Texas, California, Missouri, Florida, and Alabama. Production for the year totaled 75.7 Mt, down slightly from that for the full year 2015.

Masonry cement data for 2015 and 2016 have been revised downward to remove material that was not masonry cement. Masonry cement shipments of about 175,000 metric tons in December 2016 were down by 5.6% from those in December

2015 (table 2C). The leading masonry-cement-consuming States were, in descending order, Florida, Texas, California, North Carolina, and Georgia; these received about 56% of December's shipments. Shipments for the year were 2.4 Mt, up by 4.65% from total shipments in 2015.

Tables 5, 6, and 7 contain import data from the U.S. Census Bureau; however, data for clinker imports into the Seattle, WA, and the Detroit, MI, customs districts do not include material trucked in from Canada on an informal entry basis. Likewise, imports of cement into the El Paso, TX, district are missing significant informal entries. For some time, imports have been increasing at rates generally higher than those for cement sales overall. In part, this reflects the collapse of imports during the recession (hence a low basis for comparison), but also the relatively low cost of imports resulting from a combination of low bunker fuel costs, modest ship chartering rates, increased ship availability, and a strong dollar. In some regions, imports are offsetting domestic production constraints related to difficulties in bringing long-idle extra kilns back online. Also, clinker imports have increased, likely temporarily, ahead of expected disruptions to kiln output at certain plants that are undergoing upgrades. December 2016 imports of cement and clinker of about 0.9 Mt were 4.1% higher than those in December 2015. Imports for January through December totaled 13.6 Mt, up by about 19% from total imports in 2015. As noted in tables 5 and 7, full-year 2016 imports were overstated by inclusion of slag import data in April and May that were misreported by the importer under the clinker tariff code.
