CEMENT IN OCTOBER 2017

This report provides monthly data on the shipments of cement to final customers and the production of clinker in the United States from January 2016 through October 2017.¹ Data on the imports of cement and clinker for October 2017 are also provided. The September through October 2017 data for Puerto Rico are preliminary owing to reporting disruptions resulting from the hurricanes in October.

Total shipments of portland and blended cement in the United States and Puerto Rico in October 2017 were about 9.4 million metric tons (Mt), up by 4.9% from shipments in October 2016 (tables 2A and 2B). The leading producing States for portland and blended cement in October 2017 were Texas, Missouri, California, Florida, and Michigan, in descending order (table 1A), and these accounted for 41% of the month's total sales. The leading cement-consuming States (Texas, California, Florida, Ohio, and New York, in descending order) received about 37% of the October shipments (tables 2A and 2B). Shipments for the year through October were 81.0 Mt, up by 2.1% from those during the same period in 2016.

Masonry cement shipments of about 217,000 metric tons (t) in October 2017 were up by 2.8% from those in October 2016 (table 2C). The leading masonry-cement-consuming States were, in descending order, Florida, Texas, California, North Carolina, and Georgia; these States received almost 55% of the October shipments. Masonry cement shipments for the year through October were 2.05 Mt, slightly higher than those for the same period in 2016.

Clinker production totaled 6.9 Mt in October 2017, up slightly from the output in October 2016 (table 4). The leading clinker-producing States in October were, in descending order, California, Texas, Missouri, Florida, and Pennsylvania, and these States accounted for 50% of the total production for the month. Clinker production for the year through October totaled 63.6 Mt, nearly identical to that for the same period in 2016.

Tables 5, 6, and 7 list import data from the U.S. Census Bureau; however, data for clinker imports into the Seattle, WA, and the Detroit, MI, customs districts do not include material trucked in from Canada on an informal entry basis. Likewise, imports of cement into the El Paso, TX, district are missing significant informal entries from Mexico. Imports increased in 2016 and the first quarter of 2017 at rates well in excess of overall cement consumption trends owing to a combination of slow recovery of domestic production, a strong dollar, and low ship chartering rates and bunker fuel costs. More recently, however, import volumes have been erratic relative to the same months in 2016. October 2017 imports of cement and clinker of about 1.2 Mt were slightly less than those in October 2016. As listed, imports for the year through October totaled 11.5 Mt, essentially unchanged from the total for the same period in 2016. The 2017 total is understated by January imports of nearly 28,000 t of gray portland cement imported into the San Francisco Customs district under a tariff code for another commodity.
