SODA ASH IN FEBRUARY 2007

Natural soda ash production in February was 880,000 metric tons (t), 2% higher than the previous month's production of 864,000 t, according to the U.S. Geological Survey. Ending inventories were 227,000 t, 13% lower than the preceding month's inventories. Wyoming trona production in February was 1.4 million tons. Total production of chemical caustic soda was withheld to avoid disclosing company proprietary data.

Apparent consumption of soda ash in January was 513,000 t, 9% lower than in January 2006.

Exports and imports of soda ash in January 2007 were 381,000 t and 477 t, respectively.

The trends in cumulative soda ash statistics through January 2007, compared with those of January 2006, were as follows: production was 9% lower; imports, 29% lower; exports, 14% lower; and apparent consumption, 9% lower.
