SODA ASH IN JULY 2009

U.S. natural soda ash production in July was 794,000 metric tons (t), 9% higher than the previous month's production of 731,000 t, according to the U.S. Geological Survey.

Ending inventories for July 2009 were 219,000 t, 12% lower than the preceding month's inventories. Wyoming trona production in July was 971,000 t. Total production of chemical caustic soda was withheld to avoid disclosing company proprietary data.

Apparent consumption of soda ash in June 2009 was 462,000 t, 14% higher than that of June 2008, and ending stocks were 18% higher.

Exports and imports of soda ash in June 2009 were 292,000 t and 200 t, respectively.

The trends in soda ash statistics for June 2009, compared with those of June 2008, were as follows: production was 22% lower; imports were 82% lower; exports were 45% lower; and apparent consumption, 14% higher. Global economic problems have reduced world soda ash consumption, which in turn has reduced U.S. soda ash exports. To avoid an oversupply of soda ash inventories, domestic soda ash production has been cut back intentionally, but should begin to increase because the export market is forecast to improve in the next few months.

All percentages in this report were computed using unrounded data.
