SODA ASH IN MAY 2014

U.S. natural soda ash production in May was 890,000 metric tons (t), 4% lower than the previous month's production of 926,000 t.

Ending inventories for May 2014 were 324,000 t, slightly lower than the preceding month's inventories. Wyoming trona production in May 2014 was 1.56 million metric tons, about 4% lower than in April 2014.

Exports and imports of soda ash in March 2014 were 570,000 t and 3,830 t, respectively.

The changes in soda ash statistics for April 2014, compared with those of April 2013, were as follows: production was 4%

higher; imports were 18 times higher; exports were 7% lower; and apparent consumption was 2% lower. Soda ash import tonnages can vary widely from month to month, but generally are of much smaller volume than soda ash export tonnages. All percentages in this report were computed using unrounded data.
