SODA ASH IN AUGUST 2016

U.S. natural soda ash production in August was 984,000 metric tons (t), 7% less than the previous month's production and slightly more than that of August 2015 (table 1).

Ending inventories for August 2016 were 314,000 t, 12% less than the preceding month's inventories. Wyoming trona production in August 2016 was 1.46 million metric tons, slightly less than that of July 2016 and August 2015.

Exports of soda ash in July 2016 were 531,000 t, about 16% less than those of July 2015. Imports of soda ash in July 2016 were 4,420 t, slightly lower than those of July 2015.

Production of natural soda ash in July 2016 was 6% higher and apparent consumption increased by 33% as compared with that of July 2015. Apparent consumption, exports, and

production from January 2016 through July 2016 were essentially unchanged from the same period of 2015. Soda ash import tonnages can differ widely from month to month, but generally are much smaller than soda ash export tonnages.

All percentages in this report were calculated using unrounded data.
